Abstract (Size:10 pt)

This is a sample of Proceeding paper of SENAMM I National Seminar you have to follow. The paper should be written on HVS A4 size (210 x 297 mm) papers and printed clearly using Times New Roman letter on MS-Word 6.0 or the latest version. Use two columns format (Abstract use one column format). The title and author's name (without academic degree) should be centered written on the first page with 16 pt and 12-pt-size letter, respectively. You have to begin the paper with a 200-250 word-length abstract, written with 10 pt size italic letters. Use 30-mm left and right margins. The abstract should be written in two languages (Indonesian and English) with the Indonesian version coming first.

1. Introduction

SENAMM I National Seminar Proceeding will be printed from the papers you've sent. There will be no changes if you follow this instruction for uniformity purpose : left and right margins are both 30 mm, top and bottom margins are 40 mm and 30 mm, respectively.

2. General Instruction

The paper can be written in English or Indonesian, but preferably in English. The length of the paper is 8 pages maximal including tables and pictures. The papers that exceed the page limitation will not be accepted. Use black ink only. The paper have to be sent in print-ready format with its copy diskette (3.5"), along with indication of interest form and author's personal data, consist of: author's name (with academic degree), place and date of birth, organisation/institution, correspondence address (with phone and fax number and e-mail). The paper could be sent by e-mail to the listed e-mail address. Please indicate the research group number listed in the call for paper leaflet that the paper will be presented in.

3. Direction of Paper's Writing

The whole manuscripts should be written one spacing with two columns format. The size of the letter is 11 pt. Every equation should be centered written and numbered consecutively in

parentheses. The number is placed at the end of the right margin. You can use the following format:

$$Z = W + e^{w} = (\phi + e^{\phi} \cos \Psi) + i(\Psi + e^{\phi} \sin \Psi) \quad (1)$$

$$X = \phi + e^{\phi} \cos \Psi$$

The list and number of the whole references should be put at the end of the paper. If it is mentioned in the text, write the number in brackets just like we show in the end of this sentence [1].

Bibliography

Write the bibliography with the following rules:

1. Reference from magazine/science journal/proceedings:
[number] Author, "article title", *Name of journal/proceeding*, volume, number, pages, (year).

Example:

[1] Akgerman, A. and L. Gainer, "Predicting Gas-Liquid Diffusivities", *Journal of Chemical Engineering Data*, 17, 372-377, (1972)

2. Reference from collection of papers:

[number] Author, "article title", *title of collection papers*, editor, page number, publisher, (year).

Example :

[2] Mischke, R.A, "Flash Distillation", *Series B: Stagewise and Mass Transfer Operation*, editor: E.J. Henley, p.16-21, AIChE, New York, (1980).

3. Reference from thesis/disertation:

[number] Author, "thesis/disertation title", page number, University, (year).

Example:

[3] Wu Feng, "*Kinetic Modelling of Catalytic Cracking of Paraffins and Aromatics*",

Dissertation, p.76, Universiteit Gent, (1992)

4. Reference from text book:

[number] Author, "text book title", edition, page number, publisher, (year).

Example:

[4] Reid R.C., J.M. Prausnitz dan B.E. Polling, "*The Properties of Gases & Liquids*", 4th ed., p.201, Mc-Graw Hill, New York (1988)

Number of words in the abstract should be between 200-250 words, written with 12 pt size italic letters. Use 30 mm left and right margins. The abstract should be written in two languages (Indonesian and English) with the Indonesian version coming first.
